We also provide full field care of game and see that it is quickly cleaned and delivered to a local butcher for processing. (All processing fees are the client's responsibility.) Bird processing and Coyote skinning are not included, but are available for a small fee.

- C) In the event of such a decision by OUTFITTER, you agree that any adjustment in fees for service or rescheduling of activities shall be at the sole discretion of OUTFITTER.
- D) You, the CLIENT, also agree to conduct all of your activities during this trip in a lawful and ethical manner, according to the laws and regulations of the Province of Alberta. To follow the directions and advice of your OUTFITTER and GUIDE at all times, or risk having your hunt suspended or worse, possibly being charged and fined under the Alberta Wildlife Act.
- E) You, the CLIENT, acknowledges that hunting has NO GUARANTEES of seeing or collecting the sought after game, and while OUTFITTER agrees to make every reasonable effort to assist you, the CLIENT, in collecting the aforementioned species, CLIENT agrees that OUTFITTER can not guarantee any results of hunting.
